

# **Erin Bike Hut Cycle Hire Terms and Conditions:**

By completing our Hire Agreement Form you agree to be bound by the following terms and conditions:

# **Proof of Identity**

Photo identification must be provided on the day of hire (without exception). Accepted forms of I.D are, UK Driving Licence and Passport, this will be kept and stored securely for the duration of the hire and will be issued back to the client upon return of the equipment in a satisfactory condition. If no identification is provide we request a £250 deposit is required upon collection of hire bike. This will be taken in the form of an open debit/credit card voucher, which will be destroyed upon return of the bike in a satisfactory condition.

The person signing the Hire Agreement Form will be held financially liable for any loss or damage to the equipment hired and is fully aware of these terms and conditions

#### **Security and Safety**

As the client, you understand that you are responsible for all equipment relating to this agreement. This means that you the client should take care to lock the bike to a fixed object through the frame and front wheel whenever unattended using the lock provided. The bike must be kept in a secure dry place overnight or undercover.

Helmets are available for every hire, we strongly recommend everyone wears a helmet, by signing the helmet disclaimer on the hire agreement form, you and everyone in your group assume full responsibility for any accident, injury or death which should occur as a result of taking this decision.

As the client, you understand that any cycling activity involves a certain element of risk, you are advised that any person using Erin Bike Hut hire bikes does so entirely at their own risk. Erin Bike Hut does not accept any liability for personal injury, loss or damage to property beyond its legal obligation.

No hire bike may be taken off the Island.

# RESPONSIBILITY FOR DAMAGE OR LOSS

Customer agrees he/she will return the equipment in the same good condition as when received, ordinary wear and tear accepted, and to repair and replace lost or stolen, damaged or broken bicycles or parts or to reimburse Erin Bike Hut for said equipment. Therefore regardless of the party at fault, customer understands and agrees to be responsible for the theft or damage to said equipment.

#### Cancellation of Booking

At the time of booking you will be required to pay a minimum deposit of £10 to reserve the bike during all weeks of the year apart from TT fortnight when a 50% deposit will be required due to high demand at this time. Should the booking be cancelled the deposit will fall non refundable if:-

- 1. All weeks apart from TT fortnight bookings cancelled with less than 48 hours notice deposits will be non-refundable
- 2. TT fortnight bookings cancelled with less than 7 days notice deposits will be non-refundable

# Loss of Items

Each bike comes with a pump, bottle cage, saddlebag (1x Tube, 1 x Allen keys 1 x Tyre Levers). These items are provided at a cost to Erin Bike Hut and all items should be returned at the end of hire.

Should any items not be returned the following charges will be applied.

Pump - £5.00 Bottle Cage - £4.00 Saddlebag - £18.00 Allen Keys - £8.00 Tyre Levers - £2.00

# Cycling Manner

As the hirer you agree to cycle sensibly, with respect for others and the natural habitat. You are expected to follow the highway code in particular the "extra rules for cyclists" (rule 59-82). The hirer should familiarise themselves with the controls of the bike to be hired before commencing ride and should be a competent cyclist.

# Late Returns

The hirer is responsible for the safe return of the bicycle to Erin Bike Hut or to arrange to be at the designated collection point at time arranged. Any late returns will incur a charge of £10 per bike, further charges are subject to management discretion.

# Insurance

Personal insurance cover is not included as part of the hire agreement, we strongly recommend you the hirer take out personal insurance prior to the hire period.

# Personal Health

I declare that I/we are in good health and that our eyesight is up to a good standard. I/we are not suffering from any medical condition or disability which is likely to adversely affect our normal control of the bicycle.

# **Nuisances**

Alcoholic Drinks, Drugs and Solvent Abuse - you or members of your party are not permitted to hire or use any equipment whilst under the influence of drink, drugs and / or solvents.

Failure to comply with the above will result in immediate confiscation of all equipment. Should this happen you will not be entitled to any refund or compensation and we shall be under no further obligation or liability to you.
